MINUTES OF THE 127th MEETING OF NMA

Venue - Conference Hall, NMA Hqrs, 24, Tilak Marg,

The meeting was attended by the following:


At the outset, Member Secretary welcomed the Chairperson (I/C) and members. Initiating the discussion, Chairperson (I/C) observed that expeditious action may be taken to finalise Heritage Bye laws of monuments. It was also decided that a self contained proposal to incorporate provisions of penalty for unauthorised construction in the vicinity of the monument contravening the AMASR Act may be moved through Ministry of Culture for approval of Competent Authority. Thereafter, following NOC Applications were put up for consideration:

Case No. 1

(Executive Engineer (C) DR-IX, Delhi Jal Board, Jagriti SPS Office Complex, Karkardooma Mode, Delhi)

After perusal of the application, it was observed that the project is in public interest; hence, it was decided to **recommend** grant of NOC in this case for trapping of Mori Gate Drain, Tonga Stand Drain, Magazine Drain, Sweeper Drain and Khyber Pass Drain into Ring Road/Bela Road Sewer and laying of sewer line on Rajpur Road by trenchless technology subject to the following conditions:

1. The work should be done under supervision of ASI to ensure that the proposed work may not cause any damage to the protected monument
2. There should not be any disturbance to the foundations of the Fort wall or damage to the monument due to vibrations and excavations of trench by drilling.



Case No. 2

(Dr. Ashok Sehgal, Principal, Shri Ram College of Commerce, Delhi University, Maurice Nagar, Delhi-110007)

After perusal of the application, it was decided to recommend grant of NOC in this case for construction of third and fourth floors over existing GF+2 floors, with the total height of building to be restricted to 22.95 m; with floor area T.F. – 676.536 sqm, F.F. – 676.536 sqm.

Case No. 3

(Prabandhak , Circuit House, Ajmer, Rajasthan)

After perusal of the application, it was decided to ask the applicant to submit the detailed information on the proposed work plan i.e. floor area, height of construction alongwith the authenticated building plan. Thereafter, the case will be re-considered.

Case no. 4

(M/s Essar Oil Ltd., Present – Essar Oil Ltd., A-5, Sector-3, Noida, Agra)

After perusal of the application, it was decided to recommend grant of NOC in this case for construction of Retail fuel station by Essar Oil Ltd, with GF for sales building.


Case no. 5

(Sri Dinesh Kumar, Regional Tourist Officer, Agra)

After perusal of the application and presentation given by the applicant, it was decided to ask for following information/clarification:

1. Comments of DG, ASI to be obtained in this matter
2. Applicant should submit the DPR and Supreme Court approval/order
3. The report of joint inspection done alongwith local ASI officers, to be submitted
4. ASI and UP(tourism) to work in coordination to avoid any kind of duplicacy in both of their projects

On receipt of all these information/comments, the case would be re-considered at NMA.



Case no. 6

(Managing Director, Health System Corporation, Health & Family Welfare Complex, Health & Family Welfare Complex, Phase-6, Ajitgarh, SAS Nagar, Punjab)

After perusal of the application, it was decided to **recommend** grant of NOC in this case for construction of Ground Floor+3 floors with the total height of 14.63 mtrs including mumty, parapet, water-tank etc. with floor area G.F. – 1038.10 sqm, F.F.–1038.10sqm. S.F.-1038.10 sqm T.F. - 48.79 sqm

Case no. 7

(Managing Director, Health System Corporation, Health & Family Welfare Complex, Health & Family Welfare Complex, Phase-6, Ajitgarh, SAS Nagar, Punjab)

After perusal of the application, it was decided to **recommend** grant of NOC in this case for construction of Ground Floor with the total height of 4.26 mtrs including mumty, parapet, water-tank etc. with floor area G.F. – 108.12 sqm.

After perusal of the application, it was decided to **recommend** grant of NOC in this case for construction of Compound wall with the total height of 2.13 m.


Case No. 14

(The District Surgeon, District Hospital, Dharwad, Civil Hospital (District Hospita!) Killa, Dharwad)

After perusal of the application, it was decided to **recommend** grant of NOC in this case for the following:

- 1) Renovation to existing Mangalore tiled roof by replacing RCC slab for special ward block with GF and 5 m height and with floor area 224 sqm
- 2) Old Hospital to be demolished for re-construction of Maternity block with GF+1 floors and 8.75 m height and with floor area GF=FF= 289.38 sqm
- 3) Renovation to existing Mangalore tiled roof by replacing RCC slab, for Special ward (Single Bed unit) block with GF and 5 m height and with floor area GF=589.38 sqm
- 4) Old Hospital to be demolished for re-construction of ward block with GF+1 floors and 9 m height and with floor area GF=FF= 650.18 sqm
