MINUTES OF THE 136th MEETING (1st Day) OF NMA

Agenda No. 1

The minutes of 135th meeting held on 28th March, 2016 were confirmed.

Agenda No. 2

Discussion on the case of 14, Janpath Lane, New Delhi: Member Secretary briefed the Authority about the present position in respect of 14, Janpath Lane, New Delhi. Shri Shiv Darshan Singh, the original owner of the plot filed Writ Petition in High Court of Delhi in which NMA has also been made respondent. The petitioner prayed for a direction to NMA to revoke the NOC granted for repair & renovation. The Government Counsel has been briefed about the case. The outcome of the petition will be awaited for further necessary action. A reference may be made to Ministry of Law about the stand to be taken by NMA, if necessary.

Agenda No. 3

Discussion on the cases of J-4 & J-13, Green Park, New Delhi:

A letter was received from Additional PS of Hon'ble Minister for Culture dated 8th January, 2016, informing that there were allegations of wrong measurement of distances of Plot No. J-4 Green Park and Plot No. J-13 Green Park from the Centrally Protected Monument "Dadi Poti Gumbad". It was also alleged that these plots were partially in the prohibited area and the construction activity of these plots was being carried out within the prohibited limits of the monument.

National Monument Authority was advised to take immediate remedial action in these two cases till the time a proper investigation was carried out to determine the correct factual position.

Accordingly, vide letter dated 20.01.2016, show cause notices were issued to the owners of Plot No. J-4, Green Park and Plot No. J-13, Green Park, New Delhi, calling for there explanations with detailed documents. Meanwhile, NOC in the case of J-4, Green Park and revalidation of license in the case of J-

13, Green Park was suspended. Simultaneously, the records available with NMA were forwarded to Secretary (Culture) and the office of Hon'ble Minister for Culture. Detailed explanations of owners of Plot No. J-4 Green Park and Plot No. J-13 Green Park were also received and copies of the same were forwarded to the Ministry of Culture. These cases were also discussed in NMA in its 131st, 132nd, 135th and 136th meetings.

Meanwhile these two cases were placed by the Ministry before Hon'ble Minister for Culture, who, after going through all the documents placed on record, observed that "there was no case regarding Plot No. J-4, Green Park, New Delhi. However, regarding Plot No. J-13, Green Park, investigations may be carried out". A copy of the noting made by Hon'ble Minister for Culture in F.No. 12/117/12-N (ASI Section) has been placed on record.

In the light of the above mentioned observations of Hon'ble Minister for Culture, and after considering the reply to the show cause notices received from the applicants and other related documents, the Authority upheld its earlier decision taken in 116th meeting of NMA held on 15.12.2014 to 17.12.2014, recommending grant of NOC to the applicant and owner of the Plot J-4, Green Park New Delhi. Accordingly, the Authority advised the Member Secretary to take consequent action.

As regards, J-13, Green Park, New Delhi, the Authority in the light of the observations of Hon'ble Minister for Culture and after considering the reply to the show cause notices received from the applicant and other related documents, came to a conclusion that the permission for construction on this plot was revalidated upto 17.03.2015 vide NMA's letter dated 20.03.2013 in contravention of Rule 14 of AMASRA 1958 (as amended in 2010), which stipulates that the aggregate period of license cannot exceed five years. Under these circumstances, the Authority decided to recommend to the Member Secretary to withdraw the revalidation of license granted to the applicant for construction at J-13 Green Park, New Delhi.

Agenda No. 4

Operationalization of NOC online portal: The Authority noted successful integration of NMA Online Portal with the Common Application Platform of North Delhi Municipal Committee, South Delhi Municipal Committee, East Delhi Municipal Committee and Municipal Committee of Greater Mumbai as per directive of Hon'ble Prime Minister to facilitate 'Ease of Doing Business'. It has also been noticed by NMA members that the time frame for disposal of online applications is 72 hours (i.e. 3 working days) for the CA and similar time frame is also prescribed for the disposal of the case for NMA and therefore, the online applications are required to be considered on day to day basis. The time frame for the disposal of cases in 72 hours would be applicable for Delhi and Mumbai. Regarding monuments outside Delhi and Mumbai, timeframe of 72 hours would be applicable after the formulation of heritage bye-laws for them





Member Secretary, NMA briefly explained the present position regarding framing of Heritage Bye-Laws and requested that time bound action may be taken to finalize the same by all concerned. After discussion following decisions were taken;

- Heritage Bye-Laws will be prepared on priority basis for those monuments for which
 maximum numbers of NOC applications have been received. A list of priority
 monuments will be provided to Shri T. J. Alone, Director (Monuments) by NMA. After
 segregating the list (region wise) he will forward the list of monuments to Regional
 Directors concerned. Secretary (C) & DG, ASI will also be apprised about the
 decision.
- It was decided that within one month all Competent Authority will prepare the list of monuments for which site plans are available and inform the National Monuments Authority accordingly. Thereafter, as per Act 20 E (4), Consultant/Conservation Architect should be immediately engaged for preparation of heritage byelaws for these monuments.
- 3. Competent Authorities were advised to contact other State/Central/Autonomous institutions to ascertain whether site plans/survey plans are available.
- For those monuments where consultants have been engaged, bye laws should be prepared preferably within two months.
- 5. Competent Authority (Delhi) has already been directed to procure the map prepared by GSDL which is upto date and authentic for finalizing Heritage Bye-Laws in respect of monuments in Delhi.
- 6. All the five Competent Authorities may engage Conservation Architect/Consultant for doing the exercise. They may also call for Expression of Interest to appoint Institution/Organization (preferably Government Bodies) to draft the Heritage Bye– Laws. Requisite funds will be provided to the Competent Authorities for doing the exercise.



- 7. Competent Authorities may also tie up with ISRO and obtain satellite maps of monuments taken in 1992 to identify unauthorized structures which have come up after that year.
- 8. It has been decided that the draft Template for Heritage Bye –Laws will be reexamined in the light of AMASR Act and AMASRA Rules. For this purpose Chairperson, NMA will hold a meeting on 20.05.2016 in which the Template will be finalized. Thereafter, the same may be sent to DG, ASI & CA's for framing Heritage Bye-Laws.
- 9. Regional Director (South) & Competent Authority stated that about 80%of prohibited/regulated area Megalithic Site at Pallavaram has already been encroached upon. The local people did not allow site inspection as mandated under Rule 9 (4) of CA Rules and there was mass agitation. The Deputy Collector proposed that the distance of between the monument and the construction sites may be measured from the revenue maps. This is not acceptable as it contravene the provision of AMASR Act. In the above circumstances it was decided that Competent Authority (South) may submit the ground position in the Court of law and ask for specific direction to measure the distance Vis-à-vis the provisions of the Act.
