Minutes of 142nd Meeting of NMA held on 10th & 11th November 2016

142nd Meeting of National Monuments Authority was held on 10th & 11th November 2016 at NMA Headquarters, 24 Tilak Marg, New Delhi. The following attended

Shri D.N. Dimri, CA Delhi and Director (Antiquity), ASI attended as a representative of DG, ASI.

The following decisions were taken :

- I. Agenda Item No. 1 : Revised Minutes of 141st. Meeting held on 26.9.2016
Agenda Item No. 2 of the 141st. Meeting of NMA held on 26.9.2016 was confirmed after revision as under :

On the basis of the comments received from the Members, the Agenda Item No. 2 of the minutes of the meeting may be revised as under :

"Member Secretary briefly mentioned the need to outline the procedure for conducting the meetings of National Monuments Authority (NMA) and follow Rule 15 and Rule 16 of NMA Rules strictly. In case of difference of opinion on any agenda item, the issue may be raised in the meeting itself so that appropriate decisions can be taken and recorded in the minutes. "

Members pointed out the provisions of Sub-rule (2) of Rule 9 of the National Monuments Authority (Conditions of service of Chairperson and Members of the Authority and Conduct of Business) Rules 2011 which reads as under :

"The Authority shall examine the application after taking due note of the observations of the Member Secretary and make recommendations specifying condition as it may deem fit to the Competent Authority. "

In response to the above, MS clarified that every item put up before the authority as as agenda item, is first scrutinized in his office and thereafter he goes through the entire proposal and after finding it fit on the basis of information placed before him, he seeks the approval of the Chairperson for placing it before the Authority.

II. Agenda Item No. 3 of the 141st. Meeting of NMA held on 26.9.2016 was discussed in details and it was decided to modify the same as under :

a) 6 Heritage Bye-laws which were approved by NMA in earlier meetings will be revised after inclusion of the parameters prescribed in Schedule I and Schedule II in the light of the facts that the approved Heritage Bye-laws for the monument at Parel, Mumbai did not prescribe for any height restriction whereas the Heritage By-laws for 3 monuments of Kolkata prescribed a height restriction of 18 Mtrs.(despite the fact that buildings in their vicinity had much higher height) It was decided that NMA shall visit Kolkata and Mumbai for spot inspection of these monuments and thereafter take a decision as per settled policy. If found necessary, the monuments of the remaining 4 approved bye-laws may also be visited by NMA for spot inspection. Thereafter NMA will consider and review the heritage bye-laws earlier approved after inclusion of information of Schedule I and Schedule II parameters.

b) ASI will be requested to take up total station survey of the monuments covered by these six approved heritage bye-laws in the first instance.

c) ASI will be requested to prioritise the monuments covered under the 9 heritage bye-laws which have been framed and are under consideration of NMA in the next instance.



Item Item No. III

Member Secretary apprised the Authority about the background of the case and informed about the letter received from the Ministry of Culture regarding advise given by Ministry of Law in respect of determining the distance of site from the Centrally Protected Monuments from the nearest point to nearest point. It was mentioned that

- i) NMA recommended grant of NOC for J-4 Green Park in the 16th meeting held on 15-17 December 2012 as per the recommendation of the then Competent Authority.
- ii) However, it was brought to the notice of NMA by Ministry of Culture that there are allegations of wrong measurement of distance in the case of J-4 Green Park, New Delhi and that appropriate remedial action may be taken. Based on the communication received, the matter was re-considered and the NOC was suspended in its meeting held on 19.01.2016.
- iii) The decision of NMA was conveyed to the Ministry of Culture with full facts of the case. After consideration of the documents on record the Competent Authority in Ministry of Culture decided that there was no malafide in the case of J-4 Green Park, New Delhi. Thereafter the suspension was revoked by NMA in its meeting held on 16.05.2016.

However, now in view of the advise given by Ministry of Law regarding the interpretation of AMASR Act, NMA decided to review its decision. It was decided that the recommendation for grant of NOC in this case may be withdrawn. It was further decided that henceforth the distance of site of construction from the Centrally Protected Monuments will be measured from the nearest point to nearest point. The above decision may be communicated to Competent Authority, Delhi for further necessary action. It was also decided that an advisory may be issued to all Competent Authorities to follow the directions of Ministry of Law in future.



AGENDA ITEM NO. 4

Member Secretary briefed the Authority about the RTI applications received in NMA regarding fake NOCs from Surat, Gujarat. After investigation and scrutiny of documents in NMA, it was found that there are 3 cases where prima facie such fake documents have been used by the persons concerned. From a further investigation of documents in the office of Competent Authority, Gujarat, 6 more cases have come to the notice of NMA. The matter was brought to the notice of Ministry of Culture and it has been decided that Chief Secretary, Gujarat may be requested to direct Competent Authority, Ahmedabad and Director (Archaeology) of State, to file an FIR in Surat, which is the place of cause of action. The Competent Authority Gujarat and Superintending Archaeologist, Vadodara may be directed to make on the spot investigations and submit a report. It was also decided to ask Director General, ASI to take appropriate action against the unauthorized constructions.

The developments reported by Member Secretary were noted. It was decided to send advisory to all Competent Authorities to review all cases of NOCs issued by them and find out whether any irregularity is involved.

Similar advisory may be sent to Director General, ASI with the request to circulate it amongst the Superintending Archaeologists.

Additional Agenda 1 (A)

Kolkata Metro Rail Project, Kolkata :- Sh. Alapon Bandhopadhaya, Principal Secretary, Transport, Govt. of West Bengal and Chief Coordinator of East- West Metro project of Kolkata made a presentation before the authority regarding the project and explained that since the construction will be mainly confined to tunnelling, this activity will have no impact on the centrally protected monuments. Secondly, an Impact Assessment Report has been conducted by IIT, Kharagpur in which it has been observed that there will be no impact of tunnelling activity upon the monuments.

Member Secretary, explained that as per AMASR Act, no construction activity can be permitted within the 100 mtr of the monument in all directions which includes over and under the ground constructions. Ministry of Law has also clarified in another case of construction, that there is no provision for relaxation in this regard even in cases of public projects or public utility activities. Under these circumstances, NMA is not in a position to recommend NOC in this case. It is for the Archaeological Survey of India (ASI) to take appropriate action as any activity in the prohibited area comes under their jurisdiction.


R.D Shenoy, M/s Ramnani associates, Mumbai: - After perusal of the application and the representation by the applicant, it was observed that since the construction activity being undertaken by the applicant is at 314mtr from the protected limit of Sion fort, it falls beyond the limits of regulated area (300mtr) and therefore no NOC is required from NMA. However, it was decided to ask the CA to ensure that no construction ~~activity~~ activity should take place within the regulated area of "Sion Fort".
