Additional Agenda No. 2

Proposed amendment to AMASR (Amendment & Validation) Act, 2010

The proposed amendment of AMASR Act, 1958 circulated by Archaeological Survey of India (ASI) was discussed. The Authority supported the proposed amendments as envisaged in the draft Cabinet Note. However, the Authority is of the view that the powers vested with NMA under Section 22(I)(e) reproduced below should not be diluted.

"To consider the impact of large-scale developmental projects, including pubic projects and projects essential to the public which may be proposed in the regulated areas and make recommendations in respect thereof to the competent authority."

Secondly, NMA is also of the view that alongwith public projects funded by Central Government, similar projects of State Government may also be included in the definition of "Public Works" in Section 2 of the Act.

The above observation of NMA will be communicated to ASI.
