The minutes of 167th meeting held on 18th December, 2017 were confirmed.

Agenda No. 2

Consideration of Public Projects

Case No. 1

(Pracharya, Rameshwari Devi Rajkiya Snaatkotar Kanya Mahavidyalaya, Bharatpur, Rajasthan)

After perusal of the application, it was decided to **recommend** grant of NOC in this case for repair and renovation of existing building at Rameshwari Devi Rajkiya Snaatkotar Kanya Mahavidyalaya but for new construction, detailed plan with plinth area etc. to be submitted. Thereafter, the case will be considered again.

Case No. 2

(Executive Engineer , Pariyojana Khand Dwitiya, Public Health Engineering Department , Jaipur, Rajasthan)

After perusal of the application, it was decided to **defer** the case and ask the applicant to submit the complete technical details of the proposed construction work. Thereafter, the case will be considered again.



Case No. 3

(Mahamongkolchai Dhamma Devoted Land for World Peacefulness Foundation, Village-Katra, Ikauna, Distt. Shravasti)

After perusal of the application, it was decided to **recommend** grant of NOC in this case for construction of boundary wall with iron fencing at Village-Chakrabhandar Ikauna, Distt. Shravasti- Plot No. 93/0.070 hect., 120/0.216 hect., 153/0.033 hect. & 154/0.066 hect.; with the total height of boundary wall 3.50 mtr.

Case No. 4

(Madhya Pradesh State Tourism Development Corporation, Bhopal, Madhya Pradesh)

After perusal of the application, it was decided to **recommend** grant of NOC in this case for the tourism development related work at Khasra No. 81/2, Village – Naingoan, Tehsil- Circle 2 Kukshi, District- Dhar (MP); subject to the compliance of the suggestions/conditions as per the Annexure forwarded by SA, Bhopal. It was also made clear that the proposals for construction of library, boundary wall and gate will not be allowed as a part of this development work.

Case No. 5

(Secretary, Scindia Education Society, Gwalior, Madhya Pradesh)

After perusal of the application, it was decided to **recommend** grant of NOC in this case for repair and renovation of existing security office building at Survey No. 350 and the ATM may be placed within the existing security office, as proposed in Form I.

Case No. 6

(M/s. Engineers India Ltd. 113/154, Swarup Nagar, Kanpur (UP))

After perusal of the application, it was observed that M/s. Engineers India Ltd. is only the executing agency for the proposed repair and renovation work and hence, the application should come from the Mission Director of NMCG. Therefore, the case was deferred for now.

Case No. 7

(Principal I/C , Sibsagar Girls' College, Near Shiva Dol, P.O. and Dist Sivasagar, Assam)

After perusal of the application, it was decided to **recommend** grant of NOC for the proposed repair and renovation work of the Institutional building as per Rule 6 and 8 of AMASRA Rules, 2011 without any change in exterior structure and without any vertical/horizontal extension.



Case No. 8

(Deputy Conservator of Forests, Vanbhavan, Station Road, Oppo SSC Board, Osmanpura, Aurangabad, Maharashtra)

After perusal of the application, it was decided to **defer** the case and ask the applicant to come for a PowerPoint Presentation with the detailed proposed plan of the project. Thereafter, the case will be considered again.

Case No. 9

(Tourist Officer, Department of Tourism, Government of Uttar Pradesh, UP)

After perusal of the application, it was decided to **defer** the case and ask the applicant to come for a PowerPoint Presentation with the complete site plan and details of the proposed project. Thereafter, the case will be considered again.

Case No. 10

(Sh.Shivam Pateriya representation of M/s Cengrs Geotechnical Pvt. Ltd., New Delhi)

After perusal of the application, it was observed that M/s Cengrs Geotechnical Pvt. Ltd. is ~~only the executing agency for the proposed geo-technical investigation and hence, the application should come from the DMRC. Therefore, the case was deferred for now.~~

Case No. 11

(The President Bellary District Kurubara Sangha , Ward no. 33, Devi Nagar, Bellary, Karnataka)

After perusal of the application, it was decided to **recommend** grant of NOC in this case for construction of GF+1+Mezzanine floor of community building with the total height of 12.42 mtrs. (including mumty, parapet, water-storage tank etc.) at TS No. 370/1c, 370/1d & 370/2, Kurubara Sangha, Infantry Road, Ballari; floor area of GF=FF=774.90 sqm. & Mezzanine=774.90 sqm. The applicant should send the detailed architectural plan for approval.

Case No. 12

(The Chairman, Karnataka Education Board, Malamaddi, Dharwad, Karnataka)

After perusal of the application, it was decided to **recommend** grant of NOC in this case for construction of Ground Floor of toilet blocks for boys and girls with the total height of 3.86 mtrs. (including mumty, parapet, water-storage tank etc.) at CTS No 131/5/MF, Karnataka High School, Dharwad; floor area of GF=87.27 sqm.



Agenda No. 3

Discussion on Categorization of Monuments

The matter relating to categorisation of monuments was discussed. Director (Monuments), ASI was requested to clarify the position regarding compilation of information in this regard.

Director (Monuments) has stated that the information on the following points could be made available in the first phase of preparation of monument dossiers.

- a) Gazette notification of Central Government declaring the monument of national importance.
- b) Archaeological details of the monument.
- c) Historical background of the monument.
- d) Aesthetic of cultural significance of the monument.
- e) Religious background in case of living monuments.
- f) Annual footfall/ visitor data for minimum 5 preceding years.
- g) Copy of the notification whereby ticketing was introduced for the visitors with latest ticket rates for different categories of visitors.
- h) Annual income from ticketed entry, for last five years.
- i) Details of civic amenities for the visitors.
- j) Details of encroachments, if any and the population pressure to the monument.

However, information on points (b), (c), (d) and (e) may form a single unit covering all required aspects associated with the monument. It may also be noted here that every monument may not have all the above components.

Director (Monuments) has also stated that the information on the following points may be compiled in the second phase of preparation of monument dossiers.

- k) Copies of ASI publication elaborating the significance of the monument
- l) Bibliography of published research work in respect to the monument.
- m) Still and video photography of the monument and its surroundings covering prohibited and regulated area
- n) Site Plan of the monument.
- o) Architectural drawings of the monument
- p) Details of the restoration/ conservation work taken up by Archaeological Survey of India.

In reference to point (k), it should be mentioned that the information is very vast in nature. Monuments like Konarak, Ajanta, Taj etc may have volumes of books. Such information would be difficult to keep in a 'monument dossier.' However, all circle/mini circles may ensure availability of concerned literature/books in their library.

Information with respect to point (m) and (n) is a long term project on which ASI is working on.

After discussion, it was decided to request ASI to complete the monument dossiers for Lucknow, Agra and Sarnath circles on priority for which categorisation is in progress. The



dossiers may be submitted by 28th February 2018. As regards those 915 monuments already categorised and approved by NMA may be referred back to M/o Culture for issuing notification.

Consideration of NOC applications

Deferred Cases

Case no. 1

(Shri Anupam Sachdev and Shri Anhad Sachdev through its SPA Shri Ravinder Dayal, S 296, Panchsheel Park, New Delhi)

After perusal of the application and the submitted Schedule II, it was decided to **defer** the case and send back the proposal. The Schedule II information should come through a Conservation Architect. Thereafter, the case would be again considered.



Case no. 2

(Sh. S.L. Bairwa, EE(PR,)-1/CLZ, North DMC , New Delhi)

After perusal of the application and letter from CA, Delhi, it was decided to **defer** the case with the following comments :

- a. It is for North MCD to negotiate with INTACH
- b. NMA or CA, Delhi are not involved
- c. North MCD can directly pay INTACH

The case will be considered only after the receipt of Heritage Impact Assessment report.

Case No. 3

(Smt. Pushpa, Tamil Nadu)

After perusal of the application and the submitted Schedule II, it was decided to **recommend** grant of NOC in this case for construction of residential cum commercial building with the total height of building restricted to 8.0 mtrs. (including mumty, parapet, water-storage tank etc.) at Old S. No. 123, New Sub Division no. 123-7A1, Patta No. 644 & 691, Plot No. 107, 108 & 109, Mamallapuram Town Panchayat, Thirukazhukundram Taluk, Kanchipuram District-603105. A copy of revised building plan with the total height of building 8.0 mtrs. (inclusive all) should be submitted by the applicant accordingly for consideration.

After perusal of the application and information submitted by CA, it was decided to **recommend** grant of NOC in this case for construction of residential building with the total height of building restricted to 18 mtrs. (including mumty, parapet, water-storage tank etc.) at B-21, Nizamuddin East, New Delhi. The construction of basement is also allowed in this proposal. A copy of revised building plan with the total height of building 18.0 mtrs. (inclusive all) should be submitted by the applicant accordingly for consideration.

After perusal of the application and clarification submitted by CA, it was decided to **recommend** grant of NOC in this case for construction of residential building with the total height of 18.0 mtrs. After perusal of the application, it was decided to **recommend** grant of NOC in this case for construction of Ground Floor of residential building with the total height of 3.95 mtrs. (including mumty, parapet, water-tank, etc.) at Sy No. 562/3, Village Kaduppassery, Panchayath Velukara, Taluk Mukunthapuram, Dt. Thrissur; plinth area of GF=57.72 sqm. The construction work should incorporate Mangalore tiled sloping roof and the color scheme of the monument should be kept in view while constructing the building.
