Case no. 01

(Sh. Girish P Chaudhuri, Gharkul, CHS B wing, 1st floor, Azad road, Vile Parle (E) , Mumbai-57)

After perusal of the application, it was decided to defer the case and ask the Competent Authority to submit specific recommendation for this project.

After perusal of the application and considering the inspection report, recommendation of the Competent Authority of Gujarat and report submitted by Superintending Archaeologist, ASI, Vadodara circle vide letter dated 30th January, 2020, it was decided to reject the revised application and ask the Competent Authority to take necessary action against the violation as
