Case no. 1

(Punjab Urban Planning and development authority, Guru Teg Bahadur Complex, Crystal Chowk, Amritsar, Punjab Pin No. 143001)

After perusal of the application, it was decided to defer the case and ask the applicant to submit the revised plan with the total height of the building restricted to 15.24 mtr (inclusive all)

After perusal of the application and the relevant reports received from SA, ASI, Lucknow circle, it is observed that the distance from the monument is 127 m and 190 m. However, the slope of the bridge is merging with the existing road at 90 mtrs from the protected area of Bara Imambara is in the prohibited area of the monument. Secondly, it has also been observed that Show Cause Notice has also been issued to the applicant by SA, ASI, Lucknow Circle for undertaking unauthorized construction on 10.02.2020. In view of this, it has been decided that the matter will be considered by the Authority after a decision is taken by ASI in regard to proposed slope of the bridge in prohibited area and show cause notice dated 10.02.2020.
