The following NOC Applications were put up for consideration.

**Case no. 01**

(Mrs. Geetha Karakunnel, Souparnika House, Near Court Complex, Sulthan Bathery, P.O., Wayanad)

After perusal of the application, it was decided to recommend grant of NOC in this case for construction of G+1 with the total height of 8.95 m (including mumty, water storage tank, parapet etc.), with floor area of 524 sqm. and basement with depth upto 3 m.

**Case no.02**

(Mrs. Suramma (Suradha) & Others., H. No. 1/639, Kottavalappu, Fort Kochi, P.O., Ernakulam)

After perusal of the application, it was decided to recommend grant of NOC in this case for construction of G+1 with the total height of 7.35 m (including mumty, water storage tank, parapet etc.), with floor area of 124.34 sqm.
