Consideration of Online Cases

Case no. 222

(Smt. Shobha Chand, A-1/45, Masjid Moth, Panchsheel Enclave, New Delhi)

After perusal of the application, it was decided to **recommend** grant of NOC in this case for construction of Stilt+GF+3 floors with the total height of 18mtrs (including mumty, parapet, water-storage tank, lift room etc.) at A-1/45, Masjid Moth, Panchsheel Enclave, New Delhi; with floor area of Stilt=GF=FF=SF=TF=161.89 sqm.
