Case No. 1

(Shri Hitesh Jagota, C-53 Soami Nagar, New Delhi)

After perusal of the application, it was decided to **recommend** grant of NOC in this case for reconstruction of Basement+Stilt+GF+3 Floors with the total height of 18mtrs. (including mumty, parapet, water-storage tank, etc.) at C-53 Soami Nagar, New Delhi; floor area of Stilt=GF=FF=SF=TF=187.05sqm. and Basement Area: 130.56sqm. & Depth: - 2.91mtrs. The NOC is recommended to be granted with the terms and conditions mentioned in report of CA, Delhi.

Case No. 2

(Smt. Nishchint Bery and Mrs. Salochna Goyal, F-5, Geetanjali Enclave, New Delhi)

After perusal of the application, it was decided to **recommend** grant of NOC in this case for construction of Basement+Stilt+GF+3 Floors with the total height of 18mtrs.
