Public Projects

Case no. 01

(Manager, City Montessori School, Lucknow)

After perusal of the application, it was decided to **recommend** grant of NOC in this case for construction of Block E: GF+3, Block F: Basement+GF+1 with the total height of 12.04 mtrs including mumty, parapet, water-tank etc.; with floor area Block E: GF=FF=SF=TF= 508.142 sqm; Block F : GF=FF= 1849.833 sqm.
