# Consideration of Public Utility Projects

### Case No. 1

(The Chief Officer, Town Municipal Coucil, Sy. No.-61/A, Ward No. 2, Division 4, Tattakote Village, Badami, Bagalkot, Karnataka)

After perusal of the application, it was decided to **recommend** grant of NOC in this case for construction of Underground Drainage Network with total path length 457 mtrs., water supply to tanks and construction of Wash Pens with the total height of 1.750 mtrs. at Sy. No.-61/A, Ward No. 2, Division 4, Tattakote Village. The recommendation is subject to the conditions:

- 1. The proposed work should be carried out under supervision of ASI.
- The proposed work should be carried out as per conditions laid down by the Competent Authority of NMA.
- 3. The proposed work should be carried out subject to fulfilling the local bye-laws and after obtaining all statutory approvals.

#### Case No. 2

(The Chief Officer, Town Municipal Coucil, Museum Road, Badami, Bagalkot, Karnataka)

After perusal of the application, it was decided to **recommend** grant of NOC in this case for construction of road and covered drainage, solar heritage street light, manholes and lateral drains at Museum Road, Badami. The recommendation is subject to the conditions:

- 1. The proposed work should be carried out under supervision of ASI.
- The proposed work should be carried out as per conditions laid down by the Competent Authority of NMA.
- The proposed work should be carried out subject to fulfilling the local bye-laws and after obtaining all statutory approvals.

#### Case No. 3

(The Chief Officer, Town Municipal Coucil, Maine Basti, Badami, Bagalkot, Karnataka)

After perusal of the application, it was decided to **recommend** grant of NOC in this case for construction of road and covered drainage, solar heritage street light, manholes and lateral drains at Maine Basti, Badami. The recommendation is subject to the conditions:

- 1. The proposed work should be carried out under supervision of ASI.
- The proposed work should be carried out as per conditions laid down by the Competent Authority of NMA.
- The proposed work should be carried out subject to fulfilling the local bye-laws and after obtaining all statutory approvals.

### Case No. 4

(The Chief Officer, Town Municipal Coucil, Nagaralsamat, Badami, Bagalkot, Karnataka)

After perusal of the application, it was decided to **recommend** grant of NOC in this case for construction of sandstone paved road and streetlighting at Nagaralsamat, Badami. The recommendation is subject to the conditions:

- 1. The proposed work should be carried out under supervision of ASI.
- The proposed work should be carried out as per conditions laid down by the Competent Authority of NMA.
- 3. The proposed work should be carried out subject to fulfilling the local bye-laws and after obtaining all statutory approvals.

#### Case No. 5

(Ayukt, Nagar Nigam, Ajmer, Rajasthan)

After perusal of the application, it was decided to **recommend** grant of NOC in this case for development of Subhash Udyan and construction of GF+1 floor with the total height of 7.0 mtrs. (including mumty, parapet, water-storage tank etc.) as per the application in Form I and recommendation of CA in Form II. However, the water-tank is unauthorized construction and the Director General, ASI may immediately take action against unauthorized construction as per the AMASR Act, 1958.
