Fresh Cases

Case No. 1

(Shri Harjeet Singh and Shri Kamaljeet Singh, 902/290, Gali No. 2, Shalimar Village, Delhi)

After perusal of the application, it was decided to **recommend** grant of NOC in this case for construction of GF+2 Floors of steel structure with the total height of 13.65 mtrs. (including mumty, parapet, water-storage tank etc.) at Property No. 902/290, Gali No. 2, Shalimar Village, Delhi; with floor area of GF=FF=SF= 166.46 sqm.
