After perusal of the application, it was decided to **recommend** grant of NOC in this case for construction of Basement+Stilt+4 Floors with the total height of 18 mtrs. (including mumty, parapet, water-storage tank etc.) at 72, Jorbagh, New Delhi; with floor area of Stilt=37.49


