**Consideration of Online NOC applications**

**Case no. 328**

**(Shri Sunil Datt Uppal, F-5, Nizamuddin West, New Delhi)**

After perusal of the application, it was decided to **recommend** grant of NOC in this case for construction of Basement+Stilt+GF+3 floors with the total height of the building restricted to 18 mtrs (including mummy parapet, water-storage, lift machine room etc.) at F-5, Nizamuddin West, New Delhi; with floor area of Stilt=GF=FF=SF=TF= 125.39 sqm and Basement= 125.39 sqm with depth= 2.90 mtrs. The NOC is recommended to be granted with the terms and conditions mentioned in report of CA, Delhi. The applicant should follow the local building bye-laws while constructing the building.

**(Mrs Neena Madan And Mr Vivek Madan, C-32, Shivalik, New Delhi)**

After perusal of the application, it was decided to **recommend** grant of NOC in this case for construction of Basement+Stilt+GF+3 floors with the total height of the building restricted to 17.85 mtrs (including mummy parapet, water-storage, lift machine room etc.) at Plot no. 17, Block C-1, Safdarjung Development Area, New Delhi-110016; with floor area of Stilt=GF=FF=SF=TF= 186.95 sqm and Basement= 186.94 sqm with depth= 3.45 mtrs. After perusal of the application and site visit, it was decided to **recommend** grant of NOC in this case for construction with the total height of 26mtrs (including mummy parapet, water-storage, lift machine room etc.) at 77, Netaji Subhash Road, Kolkata-700001. The revised building plan for 26 mtrs (inclusive all) should be submitted to this office for approval.
