Case no. 355

(Smt Bala Garg, Sh Sachin Garg, Plot No-A-1/70, Masjid Moth known as Panchsheel Enclave, New Delhi)

After perusal of the application, it was decided to **recommend** grant of NOC in this case for construction of Basement+Stilt+GF+3 floors with the total height of the building restricted to 18 mtrs (including mumty parapet, water-storage, lift machine room etc.) at Plot No-A-1/70, Masjid Moth known as Panchsheel Enclave, New Delhi; with floor area of Stilt=GF=FF=SF=TF=161.99 sqm and Basement= 161.99 sqm with depth =3.35 mtrs.
