#### Case no. 359/1

(Shri Ashok Kumar, Plot no. 1885, Jagram Mandir Gali, Kotla Mubarakpur, New Delhi)

After perusal of the application, it was decided to **recommend** grant of NOC in this case for construction of Basement+Stilt+GF+3 floors with the total height of the building restricted to 17.38 mtrs (including mumty parapet, water-storage, lift machine room etc.) Plot No-74, Block-H, New Delhi South Extension Part-I, New Delhi; with floor area of Stilt=GF= FF=SF=TF=187.47sqm and Basement= 187.47 sqm with depth =3.00 mtrs. The NOC is recommended to be granted with the terms and conditions mentioned in report of CA, Delhi. The applicant should follow the local building bye-laws while constructing the building.
