**Case no. 387/1**

**(Shri Subhash Chander, Plot No-42, Municipal No-4953, Bharat Ram Road, Block-G, Daryaganj, Delhi-110002)**

After perusal of the application, it was decided to **recommend** grant of NOC in this case for construction of Basement+Stilt+GF+3 floors with the total height of the building restricted to 17.75 mtrs (including mummy parapet, water-storage, lift machine room etc.) at Plot No-42, Municipal No-4953, Bharat Ram Road, Block-G, Daryaganj, Delhi-110002; with floor area of Stilt=GF=FF=SF=TF=210.595 sqm and basement= 210.595 sqm with depth= 2.90mtrs. The NOC is recommended to be granted with the terms and conditions mentioned in report of Competent Authority, Delhi. The applicant should follow the local building bye-laws while constructing the building.

**Case no. 399**

**(Mrs. Jatinder Malhotra, Plot no. C-24, Malviya Nagar, New Delhi)**

After perusal of the application, it was decided to **recommend** grant of NOC in this case for construction of Basement+Stilt+GF+3 floors with the total height of the

building restricted to 18 mtrs (including mummy parapet, water-storage, lift machine room etc.) at Plot no. C-24, Malviya Nagar, New Delhi; with floor area of Stilt=GF=182.37 sqm, FF=SF=TF=180.74 sqm and basement= 177.58 sqm with depth= 2.90mtrs. The NOC is recommended to be granted with the terms and conditions mentioned in report of Competent Authority, Delhi. The applicant should follow the local building bye-laws while constructing the building.
