Consideration of offline NOC applications

Public Projects

Case no. 01

(The Executive Engineer, PWD, Building Construction Division-I, Building Construction Division-I, Chepauk, Chennai- 600005, Tamilnadu)

After perusal of the application, it was observed that the proposed re-construction of multi storied building falls within the prohibited area of nearby of CPM. Therefore, the case is beyond the jurisdiction of NMA and cannot be considered.

Case no. 02

(Secretary Municipal Committee, Farrukh Nagar, M.C. Farrukh Nagar, Distt. Gurugram, Haryana)

After perusal of the application, it was decided to **reject** the case and ask the applicant to submit fresh proposal for regulated area only.

After perusal of the application and information received from CA, Karnataka, it was decided to **recommend** grant of NOC in this case for construction of ornamental grills compound with the total height of 4.10 mtrs at Temple Property (Government). Nanjangudu.

After perusal of the application, it was decided to **defer** the case and ask the SA to submit a detailed status report on the present proposed site.

After perusal of the application, it was decided to **recommend** grant of NOC in this case for construction of GF+1 floor with the total height of 7.80 mtrs (including mummy parapet, water-storage tank etc.) at ASST. No. 279, D.no. 236, 9th Ward, Panduranga Colony, A.S. Gudi, Hospet; with floor area GF= FF= 66.50sqm.

After perusal of the application, it was decided to **recommend** grant of NOC in this case for construction of GF+1 floor with the total height of 7.20 mtrs (including mummy parapet, water-storage tank etc.) at K.NOS 630A/590/514A & 630B/590B/514, Darga Road, Madhugiri Town, Madhugiri Taluk; with floor area GF= FF= 87.53sqm.
