**Case no. 01**

**(The Executive Engineer, Public Works Department, O/oThe Executive Engineer, Public Works Department, Works Division-I, Moti Daman, UT of Daman and Diu)**

After perusal of the application, it was decided that as the proposed Repair, renovation, alteration of existing sport complex fall in the prohibited area of the monument, the applicant should enter into a MoU with the Archaeological Survey of India to carry out the work further. However, it may be ensured that there is no construction as defined under section 2 (dc) of AMASR Act.

**Case no. 02**

After perusal of the application, it was decided that as the proposed Reconstruction and Strengthening of existing internal road inside fort area i.e. in the prohibited area of the monument, the applicant should enter into a MoU with the Archaeological Survey of India to carry out the work further.
