However it has been observed that in the above mentioned letter the applicant requested for grant of NOC for underground metro construction in regulated area of 3 monuments (Agra Kila, Delhi Gate & Jama Masjid) whereas they reiterated their request for grant of NOC for elevated metro construction in the regulated area of 4 monuments, which is not in accordance with the decision of NMA. Under these circumstances it was decided to reiterate the earlier decision of NMA in its 280th meeting held on 18th September, 2020.
