The Member Secretary, NMA informed the Authority that the file relating to Heritage Bye-Laws of Amjad Ali Shah's Mausoleum has been returned by the Ministry of Law with the remarks that "the bye-laws shall be made by the Authority, as per the Rules made by the Central Government and the Ministry of Law and Justice (Legislative Department) does not require to vet the same." However, the draft has been examined by them and corrections have been made in pencil. It was decided to examine the suggestions/corrections made by the Legislative Department in the next meeting along with finalization of the Heritage Bye-Laws of Humayun's Tomb-Batashewala- Sunder Nursery group of monuments.

The Authority also decided that both the Heritage Bye-Laws of Amjad Ali Shah's Mausoleum as well as Humayun's Tomb-Batashewala- Sunder Nursery group of monuments shall be finalized well in time, so that, they can be forwarded to the Ministry of Culture for placing before both the Houses of the Parliament during the ensuing winter session, starting in November 2018.

It has also been decided to hold a meeting on 11/9/2018 to discuss the modifications suggested by Ministry of Law on the Heritage Bye laws of Amjad Ali Shah's Mausoleum.
