Case no.1

(CPWD through its Executive Engineer Shri Akhelesh Kumar, New Delhi)

After perusal of the application and the PowerPoint presentation by applicant, it was decided to defer the case and ask the applicant for the following information:

- i) To clarify proposed building height in the light MPD 20/21
- ii) To submit the affidavit by MHUPA
- iii) To submit complete architectural plan
- iv) To ensure no structure/activity to be carried out in prohibited area of CPM
- v) DUAC comments to be furnished

After perusal of the application, it was decided to **recommend** grant of NOC in this case for construction of Basement+Stilt+GF+3 floors with the total height of 18mtrs (including mumty, parapet, water-storage tank, lift room etc.) at Plot no. 10, block D-1, Hauz Khas, New Delhi; with floor area of Stilt=GF= 89.95 sqm, FF=SF=TF=86.63 sqm and basement area = 42.30sqm with depth = 2.90 mtrs.
