**Reconsideration Cases**

**Case No. 01**



**I. Categorization of 915 Centrally Protected Monuments**

- a. The Categorization of 915 Centrally Protected Monuments was put on the websites of NMA and ASI for inviting suggestions/ objections, if any, for a period of 30 days. No Objections/ Suggestions were received till 23rd March, 2019, i.e. the last day of the period of 30 days. The Authority





approved the Categorization of 915 Monuments of the circles of Bhopal, Chandigarh, Delhi, Kolkata and Vadodara and decided to send the same to Ministry Of Culture for issuing notification.

- b. It was also decided to conduct a meeting relating to Categorization of Monuments with the remaining circles of ASI to complete the Categorization of all Centrally Protected Monuments.

## **II. Heritage Bye-Laws of Nizamuddin Basti group of monuments**

- a. The Authority considered all the suggestions/objections received in respect of draft Heritage Bye-Laws of Nizamuddin Basti group of monuments in its meeting dated 26<sup>th</sup> and 27<sup>th</sup> March, 2019.
- b. The Authority, after going through all the suggestions/objections and after interacting with the stakeholders, residents of Nizamuddin Basti, Councillor (Ward No- 55S) and other Associations who desired to put their case before the Authority in person, agreed to make some changes in the document which were in its purview and legally viable.
- c. The corrected version of the Heritage Bye-Law of Nizamuddin Basti group of monuments will be placed before the Authority in the next meeting.
