After perusal of the application, it was decided to **recommend** grant of NOC in this case for construction of Basement+Stilt+GF+3 floors with the total height of 17.99 mtrs (including mumty, parapet, water storage tank, lift room etc.); at C-1, Hauz Khas, New Delhi-110016; with floor area of Stilt=GF=FF=SF=TF= 187.49 sqm and basement = 187.49 sqm with depth = 2.90 mtrs.
