Consideration of NOC applications

Public project

Case no. 01

(Project Administrator, S.S.P.I.U, Shamgarh, Mandsaur, MP- 458883)

After perusal of the application, it was decided to **defer** the case and ask the applicant to get Heritage Impact Assessment and Vibration Impact Assessment to be prepared by INTACH/SPA, Bhopal or any other recognised Heritage Body associating Archaeologist and Conservation Architect. It was also suggested that State Government should explore the possibility of taking the construction work beyond 300mtrs limit of the Centrally Protected Monument as adequate vacant land is available.

Defer cases

Case no. 01

(Mr. Ajmal. A, 20/1846, Suroor House, Eranattu Temple Road, Palluruthy Kochi-682006, kerala)

After perusal of the application, it was decided to **reject** the case as show cause notice was issued to the applicant for unauthorized construction.

Case no. 02

(Shri Deepak Kumar Chugh S/o Shri Kishori Lal Chugh & Shri Atul Kumar Chugh S/o Shri Kishori Lal Chugh, Maidai Mohalla, Masjid Ke Pass, Gwalior (MP) – 474003)

After perusal of the application and revised building plan from Competent Authority, Madhya Pradesh, it was decided to **recommend** grant of NOC in this case for reconstruction of GF+2 floors with the total height of 10.00 mtrs (including mumty, parapet, water storage tank etc.) at House No-1150, Zone/Ward No-4/114 Lohamandi, Gwalior; with floor area of GF=FF=SF= 64.49 Sqm.

After perusal of the application, it was decided to **reject** the case as the applicant has done unauthorized construction.

Case no. 02

(Mr. Kunju Muhammed, Thiruthikattupulakkal House, Vellarkkad. P.O., Thrissur-680584, Kerala)

After perusal of the application, it was decided to **recommend** grant of NOC in this case for construction of GF+1 floor with the total height of 7.15 mtrs (including mumty, parapet, water storage tank etc.) at Sy no. 629/P, Vellarkkad Village, Kunnamkulam Taluk, Thrissur district; with plinth area of GF=111.17 sqm, FF=51.81 sqm. The construction work should incorporate Mangalore Tiled Sloping Roof and colour scheme of the monument should be kept in view while constructing the building.

Case no. 03

(Mr. Vijayan & Vineesh, Kottilingal House, Chowannoor. P.O., Thrissur-680517, Kerala)

After perusal of the application, it was decided to **recommend** grant of NOC in this case for construction of GF+1 floor with the total height of 6.75 mtrs (including mumty, parapet, water storage tank etc.) at Re Sy. After perusal of the application, it was decided to **recommend** grant of NOC in this case for construction of GF+1 floor with the total height of 8.60 mtrs (including mumty, parapet,

water storage tank etc.) at Rs. No. 535/51, Ward no. 32, Village Bathery, Wayanad District; with plinth area of GF=150.86 sqm, FF=60.39 sqm. The construction work should incorporate Mangalore Tiled Sloping Roof and colour scheme of the monument should be kept in view while constructing the building.

After perusal of the application, it was decided to **recommend** grant of NOC in this case for additional construction on existing GF+1 floor and construction of SF with the total height of the building to be restricted to 11.20 mtrs (including mumty, parapet, water storage tank etc.) at RS no. 635/9, DIV No. 24 at S. Bathery Municipal Council; with proposed builtup area of GF=41.92 sqm, FF=157.95 sqm and SF= 161.01sqm. The construction work should incorporate Mangalore Tiled Sloping Roof and colour scheme of the monument should be kept in view while constructing the building.

After perusal of the application, it was decided to **recommend** grant of NOC in this case for construction of GF+1 floor with the total height of 7.64 mtrs (including mumty, parapet, water storage tank etc.) at RSy. No. 643/10,646/24 at Sulthan Bathery Municipality and village; with plinth area of GF=77.67 sqm, FF=64.39 sqm. The construction work should incorporate Mangalore Tiled Sloping Roof and colour scheme of the monument should be kept in view while constructing the building.

Case no. 07

(Sri. Narayanan, Karuvalath House, Anaparambu, Kattakampal. P.O., Thrissur-680544, Kerala)

After perusal of the application, it was decided to **recommend** grant of NOC in this case for construction of GF with the total height of 4.20mtrs (including mumty, parapet, water storage tank etc.) at R. sy. No. 422/3, Village and Panchayath Kattakampal, Thrissur District; with plinth area of GF=38.95sqm. The construction work should incorporate Mangalore Tiled Sloping Roof and colour scheme of the monument should be kept in view while constructing the building.

Case no. 08

(Mr. Rajeevan & Sheena, Paramban House, Kodungallur. P.O., Thiruvanchikulam, Thrissur-6806647, Kerala)

After perusal of the application, it was decided to **recommend** grant of NOC in this case for additional construction on existing GF+1 floor with the total height of the building to be restricted to 7.35mtrs (including mumty, parapet, water storage tank etc.) at Sy. No. 914/2,914/3, Ward VIII/334, Village Methala, Municipality and Taluk Kodungallur, Thrissur district; with proposed plinth area of GF=16.70sqm, FF= 50.83sqm. The construction work should incorporate Mangalore Tiled Sloping Roof and colour scheme of the monument should be kept in view while constructing the building.

Case no. 09

After perusal of the application, it was decided to **recommend** grant of NOC in this case for additional construction on existing GF and construction of stair room with the total height of the building to be restricted to 8.00mtrs (including mumty, parapet, water storage tank etc.) at Sy. No. 289/1B, Village Nattika; with proposed plinth area of Sit out=16.35sqm, Work area=14.41sqm, Stair Cabin=13.30sqm. The construction work should incorporate Mangalore Tiled Sloping Roof and colour scheme of the monument should be kept in view while constructing the building.

Case no. 10

After perusal of the application, it was decided to **recommend** grant of NOC in this case for construction of GF+stair room with the total height of 6.85mtrs (including mumty, parapet, water storage tank etc.) at Survey no. 631/2, Vellarakkad Village, Kunnamkulam Taluk, Thrissur District in Kadangode Grama Panchayath; with builtup area of GF=150.08sqm and stair room=08.89sqm. The construction work should incorporate Mangalore Tiled Sloping Roof and colour scheme of the monument should be kept in view while constructing the building.

Case no. 11

After perusal of the application, it was decided to **recommend** grant of NOC in this case for construction of FF over existing GF with the total height of 7.20mtrs (including mumty, parapet, water storage tank etc.) at Rsy no. 93/1, Ward no. XI, Village and Taluk Kunnamkulam, Thrissur district; with proposed plinth area of FF= 93.40sqm. The construction work should incorporate Mangalore Tiled Sloping Roof and colour scheme of the monument should be kept in view while constructing the building.

Case no. 12

(Sri. Kuttan Alias Mohanan, Kaipully, Kunnath Pozhath house, Ariyannoor. P.O., Thrissur-680102, Kerala)

After perusal of the application, it was decided to **recommend** grant of NOC in this case for construction of FF over existing GF with the total height of 7.30mtrs (including mumty, parapet, water storage tank etc.) at Survey no. 100/1/3, Ward no. IV/279, Village Kandanassery; with proposed plinth area of FF= 43.68sqm. The construction work should incorporate Mangalore Tiled Sloping Roof and colour scheme of the monument should be kept in view while constructing the building.

Case no. 13

(Smt. Geetha Ram Mohan, Saroj Apartments, Near Guruvayoor English Medium School, Guruvayoor. P. O., Thrissur-680101, Kerala)

After perusal of the application, it was decided to **recommend** grant of NOC in this case for construction of GF+1 floor with the total height of the building 8.05mtrs (including mumty, parapet, water storage tank etc.) and porch= 5.03mtrs at Survey no. 95/4, Ward no. IV at Kandanassery Village and Panchayat; with plinth area of GF=167.79sqm, FF=50.19sqm and porch=18.82sqm. The construction work should incorporate Mangalore Tiled Sloping Roof and colour scheme of the monument should be kept in view while constructing the building.

After perusal of the application, it was decided to **defer** the case and ask the applicants to submit revised building plan with the total height of the building to be restricted to 7.5mtrs(inclusive all) as the proposed sites fall in the CPM of "Avithathur Temple". Application having height beyond 7.5mtrs (inclusive all) in the regulated area of this monument will not be considered in future.

Case no. 17

After perusal of the application, it was decided to **recommend** grant of NOC in this case for construction of GF+1 floor with the total height of 7.16mtrs (including mumty, parapet, water storage tank etc.) at Sy. No. 1035/1P, Ward No. XV, at Kandanassery Villaged and Panchayath; with plinth area of GF= 89.60sqm and FF=22.16sqm. The construction work should incorporate Mangalore Tiled Sloping Roof and colour scheme of the monument should be kept in view while constructing the building.

The construction work should incorporate Mangalore Tiled Sloping Roof and colour scheme of the monument should be kept in view while constructing the building.

After perusal of the application, it was decided to **recommend** grant of NOC in this case for additional construction of rooms on SF with the total height of the building to be restricted to 14.59mtrs (including mumty, parapet, water storage tank etc.) at 379, DA-Block SFS Flats, Shalimar Bagh, New Delhi; with proposed floor area of SF=44.521sqm.

Case no. 26

(Mr. Rajender Kumar, 380, DA-Block, SFS Flats, Shalimar Bagh, Delhi-110088, New Delhi)

After perusal of the application, it was decided to **recommend** grant of NOC in this case for additional construction of rooms on TF with the total height of the building to be restricted to 14.59mtrs (including mumty, parapet, water storage tank etc.) at 380, DA-Block SFS Flats, Shalimar Bagh, New Delhi; with proposed floor area of TF=40.216sqm.

Case no. 27

(Mr. Deepankar Mandal, DA-152, SFS Flats, Shalimar Bagh, New Delhi)

After perusal of the application, it was decided to **recommend** grant of NOC in this case for construction of barsati on roof of TF with the total height of the building to be restricted to 14.91mtrs (including mumty, parapet, water storage tank etc.) and height of proposed additional construction = 2.75mtrs at DA-152, 3rd floor, SFS Flats, Shalimar Bagh, New Delhi; with proposed floor area of TF=19.507sqm.
