## Consideration of NOC applications

#### **Public projects**

#### Case no. 01

(Dy. Chief Engineer (construction-II) NCR, Jhansi, Office of the Chief Engineer (C-II) NCR, Jhansi-284003, Uttar Pradesh)

After perusal of the application, it was decided that proposals no. 1 to 5 fall in protected/prohibited area. Therefore, it should have been referred to ASI at the first instance.

#### Case no. 02

(The Managing Director, Telangana State Tourism Development Corporation(TSTDC) Ltd., 3-5-891, Tourism House, Beside Telugu Akademi, Himayathanagar, Hyderabad-500029, Andhra Pradesh)
