Online Cases

Delhi Case no. 476

(Mr. Sumit Gupta Th GPA Mr Neeraj Khattar, D-279, Sarvodaya Enclave, New Delhi)

After perusal of the application, it was decided to recommend grant of NOC in this case for construction of Basement+Stilt+GF+3 floors with the total height of 18mtrs (including mumty, parapet, water storage tank etc.) at D-279, Sarvodaya Enclave, New Delhi; with floor area of Basement = 125.35sqm with depth= 4mtrs, Stilt=GF=FF= SF=TF=125.35sqm. The NOC is recommended to be granted with the terms and conditions mentioned in report of Competent Authority, Delhi. The applicant should follow the local building bye-laws while constructing the building.



After perusal of the application, it was decided to **defer** the case and ask the applicant to submit the Heritage Impact Assessment (HIA) Report from INTACH/CEPT foundation or any other recognized Heritage Body associating an Archaeologist/Conservation Architect as the total built up area of the proposed construction is more than 5000 sqm. HIA should also indicate whether skyline of the monuments is broken or not.

Case no. 02

(Managing Director, Asom Paryatan Bhawan, A.K. Azad Road, Paltanbazar, Guwahati, Assam-781008)

After perusal of the application, it was decided to **recommend** grant NOC in this case for Construction of Assam type Kiosks with the total height of 3.97 mtr at Both sides in the approach road of Talatalghar (Sivasagar Town Pt-18, Dag No. 7140); with Floor area = 10.29 sqm. The color scheme of the monument should be kept in view while constructing the Kiosks.

The construction work should incorporate Mangalore Sloping Roof and colour scheme of the monument should be kept in view while constructing the building.

After perusal of the application, it was decided to **recommend** grant of NOC in this case for construction of GF+stair room with the total height of 6.60 mtrs (including mumty, parapet, water storage tank etc.) at Sy. No. 629/2, 629/4, Villarkkad Village, Kunnamkulam Taluk, Thrissur district; with Built-up area of GF=83.27 sqm.and Stair room=09.03 sqm. The construction work should incorporate Mangalore Sloping Roof and colour scheme of the monument should be kept in view while constructing the building.
