**Delhi Case no. 505**

**(Mrs. Suman Laroia, B-23, New Delhi South Extension Part-II, New Delhi-110049)**

After perusal of the application, it was decided to **recommend** grant of NOC in this case for construction of Basement+Stilt+GF+3 floors with the total height of 17.88mtrs (including mumty, parapet, water storage tank etc.) at B-23 New Delhi South Extension Part-II New Delhi-110049; with floor area of Basement =156.71sqm with depth= 3.05mtrs, Stilt=GF=FF=SF=TF=156.71sqm.
