**Karnataka 10**

**(Shri Bismilla Sayedquadari Momin, Ward No.34, Rahim Nagar, Khatun Masjid, Horti Plot, Vijaypur-586101, Karnataka)**

After perusal of the application, it was decided to **recommend** grant of NOC in this case for construction of GF+1 Floor with the total height of 7.15 mtrs (including mumty, parapet, water storage tank etc.) at Survey No. 660 B, Plot NO.74, Vijaypur, Bijapur, Karnataka; with floor area of GF=FF=63.50 Sqm.

**Karnataka 11**

**(Shree Sanjeev S/o. Sahebagouda Prabhugol, Ward No- 06, Near Solapur road Chalukya Nagar Vijayapur, Karnataka)**
