**Online Cases**

**Punjab- 21**

**(Mr. Manjit Singh, Mohalla Chimbha Nurmahal ,Tehsil Phillour, Jalandhar, Punjab)**

After perusal of the application, it was decided to **recommend** grant of NOC in this case for construction of GF+1 floor with the total height of 07.00 mtr (including mumty, parapet, water storage tank etc.) at Guru Teg Bahadur Colony, ravidas Pura Road, Jaswinder Electronics, Jalandhar, Punjab; with floor area of GF=FF=18.334 sqm.

**Punjab- 22**
