Case no. 01

(Deputy General Manager/Executive Engineer, Madhya Pradesh, Central Region, Vidyut Vitran Company Limited, Gwalior (City Division North) Roshni Ghar, Indarganj, Gwalior, MP)





After perusal of the application, it was decided to **reject** the case as we can't understand the applicable insensitivity of the Kolkata Metro toward the Beth-El-Synangongue. NMA have to preserve the monument. No construction temporary and permanent is permissible in Prohibited area of the Centrally Protected Monument as per Section 20A (4) of AMASR Act 1958.

The Authority noted that the NOC has already been approved in 223rd meeting held on 15th and 16th April 2019.
