Consideration of NOC applications

Online Case

Delhi Case no. 571

(Ms. Manju Mathur Ms Geeta Mathur Ms Mala Mathur, G-13, Hauz Khas Enclave Market, New Delhi)

After perusal of the application, it was decided to **recommend** grant of NOC in this case for construction of Basement+GF+3 floors with the total height of 17.25mtrs (including mumty, parapet, water storage tank etc.) at G-13, Hauz Khas Enclave Market, New Delhi; with floor area of Basement =99.07sqm with depth = 3.0mtrs and GF=FF=SF=TF=99.07sqm. The NOC is recommended to be granted with the terms and conditions mentioned in report of Competent Authority, Delhi. The applicant should follow the local building bye-laws while constructing the building.

Case no. 01

(Mrs. Mini Choudhary & Shri Rajiv Choudhary 107, Anand Lok, New Delhi)

After perusal of the application, it was decided to **recommend** grant of NOC in this case for construction of Basement+Stilt+GF+3 floors with the total height of 18 mtrs (including mumty, parapet, water storage tank etc.) at 107, Anand Lok, New Delhi; with floor area Basement=187.49sqm with depth= 2.90mtrs and Stilt=GF=FF=SF=TF=187.49sqm.

Case no. 02

(Shri Harish Tripathi, D-184, Saket, New Delhi)

After perusal of the application, it was decided to **recommend** grant of NOC in this case for construction of Basement+Stilt+GF+3 floors with the total height of 18 mtrs (including mumty, parapet, water storage tank etc.) at D-184, Saket, New Delhi; with floor area of Basement=156.75sqm with depth= 2.90mtrs and Stilt=GF=FF=SF=TF=156.75sqm. The Chairman directed that a site visit to have an overview of the present state of preservation of the protected monuments should be organized along with all stakeholder agencies.
