Delhi Case no. 650

(Mr. Nitin Mittal, Sh Pawan Gupta & Sh Ajay Kumar Gupta, B-7/76, Safdarjung Enclave, New Delhi.)

After perusal of the application, it was decided to **recommend** grant of NOC in this case for Construction of Basement + Stilt+GF+3 floors with the total height of 18.00 mtrs (including mumty, parapet, water storage tank etc.) at B-7/76, Safdarjung Enclave, New Delhi; with floor area of Basement = 89.84 Sqm with Depth = 2.90 mtrs and Stilt = GF=FF= SF =TF 89.84 sqm. The NOC is recommended to be granted with the terms and conditions mentioned in report of Competent Authority, Delhi. The applicant should follow the local building bye-laws while constructing the building.
