Case no. 01

(The Executive Engineer, Tamilliadu Slum Clearance Board, Division- I, Tondlar pet, Chennai 600081)

After perusal of the application and considering the fact that the proposed work for residential dwelling units fall in the prohibited area, it was decided that Regional Director and the Competent Authority, Karnataka should consider the application in consultation with Archaeological Survey of India can under the purview of the Act and refer the case to NMA with specific recommendation.



Case no. 02

(The Secretary, Bar Council of Tamilnadu& Puducherry, High Court Building, Chennai-104)

After perusal of the application, it was observed that the applicant had already constructed the building without taking prior approval. Hence, the case is rejected. It was also decided to direct the Competent Authority of Karnataka and Superintendent Archaeologist to take appropriate action the applicant for the unauthorized construction under AMASR Act. A general circular may be sent to all the Competent Authorities for taking necessary action against the unauthorized construction coming up in the regulated area of the CPMs.

After perusal of the application, it was decided that the application is for construction of road in the prohibited area. It was also decided that a policy may be drafted in case of the projects where Show Case Notice issued or Show Case Notice not issued or the extent of construction done by the applicants.
