Agenda no.1

The minutes of 250th meeting were confirmed incorporating the Heritage bye laws confirmation.

Agenda no 2

Authority considered the detailed case history. NMA had considered the case and recommended it upto a height of 22.80 m(inclusive all) without basement in its 94th meeting held on 25.11.2013.

Thereafter, two fake letters were produced by the applicant. From the letters, it has been observed that the applicant has added the basement and also increased the total height of the proposed building in violation of the permission given to him. It came to the notice that in the alleged letters, in the first one, the applicant has added one basement and in the second letter, he has increases the height upto 28.5 mtrs. The documents submitted by the applicant were verified from National Monument Authority records and it came to light that no such decision/recommendation of any NOC in this respect was made in any meeting of NMA. For further verification, information was sought from the office of Competent

Authority, Gujarat. However, as per their records also, no such application for addition of basement and increase of height upto 28.5 m was received. At present, the applicant has already completed the building upto the height 28.5 m with the basement on the site in violation of the recommendation of NMA. Therefore, the charge of unauthorized construction stands established and the same was also admitted by the applicant at the time of the personal hearing.

Now, taking into account the order of the Hon'ble High Court of Gujarat, in SCA No.7874 of 2019 the matter was considered denovo. An opportunity of being heard was given to the applicant and his advocate in 251st meeting of National Monuments Authority held on 06th November, 2019. After considering the directions given by the Hon'ble Gujarat High Court in its order dated 21.08.2019, the complete facts of the case, and also the most important fact that the illegal portion of the building was constructed on the basis of forged documents, apart from its possible implications on all other Centrally Protected Monuments across the country, National Monuments Authority has taken a considered decision in accordance with law, to Reject the case.

Agenda no 3

Decision to be taken on the illegal construction in the prohibited area reported by CA, Punjab

After perusal of the letter submitted by CA, Punjab regarding the following NOC cases, it was decided to ask the CA, Punjab to withdraw the permissions given to these applicants. The CA should take appropriate necessary action against these applicants as per Law for carrying out unauthorised construction in the prohibited area. The CA, Punjab may also be advised to give opportunity of being heard to the applicants before withdrawing these cases.



After perusal of the application and report submitted by SA, Lucknow, it was decided to defer the case for a joint site inspection in the presence of ASI.
