Detailed Advertisement for Empanelment of Surveyors

Applications in the prescribed format are invited from willing and eligible persons for consideration and Empanelment of Surveyor for deployment on need basis in various states and UTs by National Monuments Authority, a statutory body under Ministry of Culture, New Delhi.

2. <u>Mode of Empanelment:-</u>

- i. The technical nature of work required to be done by the Surveyors proposed to be provided to the Superintending Archaeologist and the Regional Directors, the specific domain knowledge of Ancient & Historical Monuments & Archaeological Sites and Remains in India will be the pre-requisite.
- ii. The empanelment of Surveyors will be confined to Retired Surveyors of ASI or State departments of Archaeology only.
- iii. The objectives of time bound completion of site inspections related to NOC applications and revalidation of site maps included in the 102 HBLs currently under the process of Heritage consultations by Expert Heritage Bodies, a decentralized approach for drawing up a panel of suitable retired Surveyors of ASI or State Departments of Archaeology.

3. <u>**Qualification:**</u> Candidates should have done diploma in Civil Engineering of three years duration or ITI course in Land Surveying of two years duration from any recognized institution recognized by the State Board of Technical Education.

4. <u>Assignment of Work</u>:- The work will be assigned to the Surveyors by the Superintending Archaeologist or Regional Director, as the case will be. The work will be either carrying out site inspections for NOC or revalidation of site maps of Centrally Protected Monuments in Heritage Bye Laws.

5. <u>Mode of Engagement</u>: With a view to achieve the objectives of expediting the pending site inspections related to NOC applications to mitigate harassment to the applicants and expediting the revalidation of site maps in the 102 HBLs currently under the process of Heritage consultations by Expert Heritage Bodies, the engagement of retired Surveyors by adopting either of the two modes of engagement namely monthly basis or on per case basis will be adopted, taking into account the stations specific conditions.

a) <u>Monthly basis</u> – The services of retired surveyors for a clearly defined time period, will be empanelled on monthly basis by the Superintending Archaeologist or Regional Director, as the case will be.

b) <u>Per Case basis</u> – Conduct of site inspections for multiple NOC applications as well as simultaneous conduct of multiple site visits for revalidation of maps of multiple CPMs, the Superintending Archaeologist or Regional Director, as the case will be, may engage retired surveyors on per case basis.

6. <u>Remuneration/Fee payable</u>:

- i. The monthly remuneration, TA/DA for site visits payable to surveyors engaged on per month basis will be governed by the provisions of Ministry of Finance, Department of Expenditure OM no. 9-25/2020 –E.IIIA dated 9.12.2020.
- ii. In case the retired surveyor is engaged on per case basis, the work of site inspection being a work of skilled nature, the fees payable to similar categories in Govt. of India will be considered as the basis for the fees payable to the retired Surveyors deployed by the Superintending Archaeologist or Regional Director for each NOC case or CPM as the case will be. The fees of Rs. 9000 per case is payable to the retired Surveyors for site inspections/ visits for each NOC case or each CPM site map revalidation. The TA/ DA for each site visit of the Surveyors will be the TA/ DA admissible to him at the time of his retirement.

7. National Monuments Authority will make direct payment of Monthly remuneration or per case fees, as the case will be and reimbursement of TA/DA for site visits based on proper certifications and other checks considered appropriate by NMA.

8. The proposed empanelment is for a limited initial period up to 31^{st} March, 2023.
